Motion to approve end of year financials as presented and continue looking for the discrepancy of \$75.15 until the February meeting by KM 2nd by GD – Motion Passed


NRCS Update


Stormwater 2019 Funding and 2020 programming

- Moving forward actions and activities for this funding will be referred to as Stormwater Partnership Programming this will include Educational Outreach and Landowner Cost-share






