## **NRCS UPDATE SUMMARY**

- A Soil Conservationist has been selected for the Bloomington Field Office and the individual, Allison Shoaf, has
  accepted the position. She does not have a start date yet. This position will serve Brown, Greene and Monroe
  Counties.
- An application has been approved and is in contract through the Wetland Reserve Program for restoration of 35 acres of hydric soil to permanent wetland in Monroe County.
- I have been getting into the field and have completed 11 site visits for EQIP 2021 potential projects. We currently have 35 customers interested in EQIP from Monroe Count and 18 customers in Brown County. I will start telling new customers from Monroe County that their applications will most likely be planned for fiscal year 2022 but I will still plan projects for fiscal year 2021 for new Brown County customers in an attempt to balance EQIP applications between Brown County and Monroe County.
